SKI/SNOWBOARD PROGRAM AGREEMENT, WAIVER, AND RELEASE

In consideration for being permitted by the Big Bear Valley Recreation and Park District to participate in the above activity, I hereby waive, release, and discharge any and all claims for damages for personal injury, death, or property damage which I may have, or which may hereafter accrue to me, as a result of participation in said activity. This release is intended to discharge in advance the Big Bear Valley Recreation and Park District (its officers, employees, and agents) from any and all liability arising out of our connected in any way with my participation in said activity, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above. It is understood that this activity involves an element of risk and danger of accidents and knowing those risks I hereby assume those risks. It is further agreed that this waiver, release and assumption of risk is to be binding on my heirs and assigns. I agree to indemnify and to hold the above persons or entities free and harmless from any loss, liability, damage, cost or expense which they may incur as the result of my death or injury or property damage that I may sustain while participating in said activity.

PARENTAL CONSENT: (to be completed and signed by parent/guardian if applicant is under 18 years of age) I hereby consent that my son/daughter, _____ participate in the above activity, and I hereby execute the above Agreement, Waiver and Release on his/her behalf. I state that said minor is physically able to participate in said activity. I hereby agree to indemnify and hold the persons and entities mentioned above free and harmless from any loss, liability, damage, cost or expense which they may incur as a result of the death or any injury or property damage that said minor may sustain while participating in said activity.

I understand that I am responsible for my child's transportation and all equipment, including bindings and their calibration, and that I am responsible for my child's supervision before and after assigned class times.

I understand that I am responsible for accident insurance for my child and that the Big Bear Valley Recreation and Park District does **NOT** provide insurance.

I understand that students are not permitted on the slopes with skis on, unless accompanied by their instructor or in possession of an area ticket or pass.

I understand that violation of any Big Bear Valley Recreation and Park Program policy regarding the Ski/Snowboard Program is grounds for suspension, without refund, from this program.

I understand that the purchase of discounted area tickets associated with this program is a privilege offered by the Big Bear Mountain Resorts (Bear Mountain & Snow Summit) and that privilege may be revoked at any time.

I HAVE CAREFULLY READ THIS AGREEMENT, WAIVER AND RELEASE AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT BETWEEN MYSELF AND THE BIG BEAR VALLEY RECREATION AND PARK DISTRICT AND I SIGN IT OF MY FREE WILL.
